## Narrative

### INCIDENT

On 12/09/22, we were dispatched to the construction area behind 700 Drayton St for a report of human remains found during digging.

### INVESTIGATION

We arrived on scene and made contact with the construction foreman who took us to the area where the bone was found. We observed what appeared to be a human bone laying next to a trench being dug. The construction crew said they were digging the trench and when the excavator bucket dropped a load of dirt and debris they observed the bone in the pile, removed it and put it on the side and called the police.

We did not touch or move the bone and stood by until Forensics and Investigators arrived on scene for scene processing. We stood by while Forensics did their investigation on scene and then we cleared the scene.

Precinct 2 supervisor was notified as well as Forensics and Homicide Investigators.

My BWC was activated during this incident.
